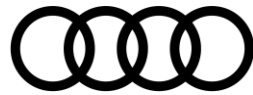


Allianz x Audi Financial Services Partnership Offer
\$5,000 Finance Contribution Terms and Conditions

1. This offer is conducted by Volkswagen Financial Services Australia Pty Ltd trading as Audi Financial Services ABN 20 097 071 460, Australia Credit License 389344 in partnership with Allianz Australia Insurance Limited ABN 15 000 122 850 AFSL 234708) of 10 Carrington Street, Sydney NSW 2000 (**Allianz**).
2. The offer commences on 4 August 2026 and closes on 31 December 2026, unless the Offer is terminated by Audi Financial Services in accordance with clause 7 (**the Offer Period**).
3. The offer is a \$5,000 finance contribution (the **Offer**) towards the financed amount of a new and/or demonstrator Audi, excluding Q3 and RS models through an Audi Financial Services designated link (the **Vehicle**). The designated link will be contained in Allianz's campaign referral channel.
4. To be eligible for the Offer, the participant must:
 - a. be at least 18 years of age;
 - b. purchase and finance a new Audi through Audi Financial Services designated link that the participant has received; and
 - c. finance the Audi for either 36, 48 or 60 months finance term; and
 - d. not be a fleet, government, rental, hire car or chauffeur company.
5. Each eligible participant may only receive the Offer once and may not use it in conjunction with other promotions and offers. Eligible participants must claim the offer via the Allianz designated link by 31st December 2026. Eligible participants must also purchase Vehicle with the offer code, with finance approved by 31st December 2026 and settled by 31 January 2027 (or as otherwise extended by Audi Financial Services). Excludes other offers. While stock lasts. Establishment fee applies (\$520 for personal applicants or \$590 for ABN holders). Other fees, charges, terms and conditions apply. 6. The \$5000 finance contribution will be automatically applied by Audi Financial Services to the Net Amount Financed.
